2020 Patient-Centered Medical Home (PCMH) Incentive Program Changes

Healthy Michigan Plan Work Requirements Update

A recent court decision means that Healthy Michigan Plan (HMP) work requirements are stopped. People with HMP do not need to tell the Michigan Department of Health and Human Services about 80 hours of work or other activities to keep their HMP healthcare coverage. Future changes to HMP will be communicated as available.

Continued Stay Reviews

Meridian is altering the time frame within which we will request clinical documentation to complete continued stay reviews for Inpatient Rehab (IPR) and Long-Term Acute Care Hospital (LTACH) settings. We will continue to work with our providers to make our members discharge planning needs a priority.

2020 Michigan Common Formulary Update

Starting April 1, 2020, MeridianHealth changed coverage for Novolog Mix 70-30 Vial and Novolog MIX 70-30 Flexpen to align with the Michigan Department of Health and Human Services (MDHHS) common formulary. Alternatives for these medications are Naproxen 250 mg tablet, Naproxen 375 mg tablet, Naproxen 500 mg tablet and others.
