

Substance Use Disorder Information Sheet

While it is always important to get your patients the treatment support they need for substance use disorder, you may not always have the information you need to provide a diagnosis. If you need assistance, we recommend the following criteria guidelines and alternative codes.

Please address substance use disorders **ONLY IF YOU ARE GOING TO FULLY ADDRESS AND DO** Initiation and Engagement Treatment (IET) of Alcohol and Other Drug (AOD) disorders. Healthcare Effectiveness Data and Information Set (HEDIS®) IET requires an initiation visit *within 14 days* of a *new AOD diagnosis* (more than 60 days since last visit) and at least *two more visits* addressing AOD disorder *within 34 days* of the initiation visit.



DSM-V Substance Use Disorder Criteria

DSM-V Substance Use Disorder* is defined as a problematic pattern of substance use leading to clinically significant impairment or distress, as manifested by at least two of the following within a 12-month period:

- 1. **Hazardous use:** You have used the substance in ways that are dangerous to yourself and/or others, i.e., overdosed, driven while under the influence, or blacked out.
- 2. **Social or interpersonal problems related to use:** Substance use has caused relationship problems or conflict with others.
- 3. **Neglected major roles to use:** You have failed to meet your responsibilities at work, school, or home because of substance use.
- 4. **Withdrawal:** You experience withdrawal symptoms when you stop using the substance.
- 5. **Tolerance:** You have built up a tolerance to the substance so that you have to use more to get the same effect.
- 6. **Used larger amounts/longer:** You have started to use larger amounts or use the substance for longer amounts of time.
- 7. **Repeated attempts to control use or quit:** You have tried to cut back or quit entirely but haven't been successful.
- 8. **Much time spent using:** You spend a lot of your time using the substance.
- 9. **Physical or psychological problems related to use:** Your substance use has led to physical health problems, such as liver damage or lung cancer, or psychological issues, such as depression or anxiety.
- 10. **Activities given up to use:** You have skipped activities or stopped doing activities you once enjoyed in order to use the substance.
- 11. **Craving:** You have experienced cravings for the substance.



Code is based on *current severity:* Note for ICD-10 codes, if substance intoxication, withdrawal, or another substance-induced mental disorder is also present, there are also comorbid codes used. Severity must also be specified:

ICD-10 Alternative Diagnosis Code Information

If a member does not currently meet AOD diagnosis criteria or you are unable to completely diagnose the disorder and would like to document counseling on the issue, use the codes below. These codes should be utilized when there is **NO current AOD or AOD history** and the goal is to counsel, watch, or refer to treat the member further with relation to substance.

If the member does not currently meet AOD diagnosis criteria or you are unable to completely diagnose the disorder and would like to document counseling on the issue, use the codes below. These codes should be utilized when there is **ONLY** a history of **AOD** and the goal is to counsel, watch, or refer to treat the member further with relation to substance.
