Patient's name, date of birth, and the date of service must be evident on ALL documentation

Measure	Documentation	Applicable Year(s)
Advance Care Planning (ACP)	A copy of documented discussion of <i>Advance Care Planning</i> in the form of an advance directive, living will, preferences for life sustaining treatment, or end of life plans/decision.	Discussion: 2022 ACP in place: anytime in patient's history
Metabolic Monitoring for Children and Adolescents on Antipsychotics (APM)	A copy of all blood glucose, HbA1c, and cholesterol labs from 2022.	2022
Breast Cancer Screening (BCS)	A copy of mammogram or digital breast tomosynthesis screening performed in timeframe.	2020-2022
Blood Pressure Control for Patients with Diabetes (BPD)	A copy of the most recent blood pressure reading of 2022.	2022
Controlling High Blood Pressure (CBP)	A copy of the most recent blood pressure reading of 2022.	2022
Cervical Cancer Screening (CCS)	A copy of cervical cytology results and date of service OR a copy of date of service with cervical cytology result AND HPV test result if aged 30-64.	2020-2022 OR If ages 30-64: 2018-2022
Childhood Immunization Status: (CIS)	A copy of the immunization record.	2020-2022
Care for Older Adults (COA)	The entire 2022 medical record; or each of the following 3 components: 1) Medication Review: A copy of the medication list AND documentation supporting a review of the medications was conducted by a prescribing practitioner or pharmacist or notation the member is on no medications. 2) Functional Status Assessment: A copy of documented discussion noting ADL or IADL assessment or the results of a standardized functional status assessment tool (e.g., Barthel Index, SF-36, EADL scale, or other ADL assessment tools). 3) Pain assessment: A copy of documented discussion indicating positive or negative findings for pain, pain score or results of a	2022

Lead Screening in Children (LSC)	A copy of the immunization record, lab reports, or progress notes with documentation of lead screening.	2020-2022
Prenatal and Postpartum Care (PPC)	Office notes, labs, prenatal flow sheet, AND postpartum visit documentation.	2021-2022
Diabetes Screening for People with Schizophrenia or Bipolar Disorder Who Are Using Antipsychotic Medications (SSD)	A copy of all glucose and Hba1c tests from 2022.	2022
Transitions of Care (TRC)	Documentation of receipt of inpatient admission notification, discharge notification, and ALL progress notes and medication lists documented within 30 days of discharge.	2022
Weight Assessment and Counseling for Nutrition and Physical Activity for Children/Adolescents (WCC)	Documentation of anticipatory guidance/education given for nutrition and physical activity. A copy of all growth charts or documentation in the chart including BMI percentile, height, and weight.	2022
Child and Adolescent Well-Care Visits (WCV)	A copy of all well-child and preventive visits member from 2022.	2022
Well-Child Visits in the First 30 Months of Life (W30)	A copy of all well-child and preventive visits member has had since birth.	2020-2022
