#### **Diabetic Supply Reference Guide Update for 2025**

Meridian is updating the **Meridian Michigan Medicaid Diabetic Supply Information & Reference Guide** for 2025. In the past, with previous bulletins and communications from Meridian in 2024 we highlighted specific diabetic supplies, and indicated these supplies were covered by the member's pharmacy benefit and/or medical benefit. #### May 2025 Michigan Medicaid Single Preferred Drug List Formulary Changes

For your awareness, **changes to our formulary have gone into effect as of 5/1/2025.** As a reminder, these changes have been previously communicated by the Michigan Department of Health & Human Services (MDHHS) and are in effect for all Michigan Medicaid managed care plans. These changes include **drugs that have been added, removed, or had utilization management restrictions adjusted** for preferred and non-preferred medications on the Single Preferred Drug List (SPDL). #### **Insulin Syringe & Pen Needle Coverage Changes (Effective 8/1/2025)**

Meridian would like to inform all prescribers and pharmacies that the coverage of certain insulin syringes and pen needle products is changing on 08/01/2025 for all members. Effective on 08/01/2025, insulin syringes and pen needles other than Embecta (formerly known as B.D.) branded products will be removed from the formulary (list of covered medications). Please refer to the full supplemental bulletin page for information regarding specific medication changes and alternative preferred insulin syringe and pen needle products.

## Public Comments to MDHHS on Michigan Medicaid Common Formulary/Single Preferred Drug List Q2 2025

The Michigan Department of Health and Human Services (MDHHS) is **soliciting comments from the public on the Michigan Medicaid Health Plan Common Formulary**. The public (including Medicaid providers) **may submit comments** on the drugs included or not included on the Common Formulary, new drug products, prior authorization criteria, step therapy criteria and other topics related to drug coverage under the Common Formulary. **Please send your comments to MDHHS by June 13, 2025**, further information and instructions for submission are available on our bulletins page.

- Recent Prior Authorization, Billing, and Policy Updates:

- Pediatric Oral Health: See the ongoing reminders page for information regarding reimbursement for oral health screenings and fluoride treatments for patients ages zero to three, and training for integrating oral health into your medical practice.
- **Hepatitis C Virus Program:** The **recommended treatment for HCV is Mavyret**, which can be dispensed in eight-week supply. Providers who have prescriptive authority can prescribe Mavyret to their patients with a positive Hepatitis C diagnosis. **Prior authorization is not required for Medicaid**.
- Medicare-Medicaid Plan (MMP) Dedicated Care Management: All MMP members have a dedicated care manager who is a registered nurse or licensed social worker assigned to support them with their healthcare needs, navigating the healthcare system, and assisting with resources for SDoH needs.
